What Does Our Washington Membership Look Like?

Our membership has grown this year!! We now have 540 members, and consist of:

381 Full Fellows (71%)	72 Associate Fellows (13%)	63 Cardiac Care Associates (12%)
23 Fellows In Training (4%)	1 Master	

Ages of the membership range from 27 to 89, with the average age 53 years old.

Electronic Prescribing Outreach Program

Beginning Jan. 1, 2009, changes to the Medicare Modernization Act (MMA), will require that all computer generated prescriptions for Part D patients comply with the NCPDP Script standard which means they must be transmitted electronically and not via fax. Over 100,000 prescribers use EMR, e-prescribing and lab order systems that could connect with pharmacy computers but don't. Even if practices think they're e-prescribing, they may be sending prescriptions to pharmacies by fax.

ACC is launching an outreach program in conjunction with number of medical specialty societies. Visit www.getrxconnected.com to complete a short assessment. Practices will then receive a free Practice Readiness Report that will confirm if your EMR, e-prescribing application or lab order system is able to connect to the pharmacy electronically. If you don't use this type of technology, you'll receive a free technology guide to help get started.

During the short session of 2008, there weren't any bills introduced into the Legislature that would directly impact your practice. Hence, the WA ACC decided against holding our Annual "Olympia Day". However, we are aware of several bills that will be dropped in the next session that if passed, will impact the majority of our members' practices.

We hope that you will consider participating in our 2009 Olympia Day – date will be determined when the Legislature set their schedule in late Fall.

Congress is poised to make decisions that will have a profound impact on the way we practice medicine. By actively cultivating relationships with lawmakers in Washington, D.C., cardiovascular specialists can influence members of Congress as they debate performance measurement, health information technology (HIT), and Medicare physician payment. Another issue of concern to Congress is payment for medical imaging services, and you are in a unique position to help us work with Congress on this issue.
